



## Dangerous Activity Permission Form

*Note: Students may only use this permission form if they have a **Dr. Walters** insurance policy. **CBYX, FLEX, and YES** scholarship students have a different Dangerous Activity Permission Form re: their insurance policy.*

*Students from countries who utilize their own insurance policy (as opposed to this Dr. Walters policy) should consult the exclusions in their policy handbook. All insurance policy info can be found on the YFU website, or by consulting your LC or SSM.*

Prior to participating in dangerous activities, students must provide this form signed by the student, natural parent(s) and host parent(s). In some cases, students must be licensed or certified in the activity and / or provide proof of supplemental liability insurance. See the "Dangerous Activities Descriptions" document for more info.

Students are expected to take adequate safety precautions and follow all local laws when participating in any kind of physical activity (i.e. helmets may be required when riding a bicycle, life jackets are required when boating, etc.). Choosing to participate in a dangerous activity that is prohibited could lead to YFU ending a student's program and / or lack of insurance coverage for medical bills that result from an accident.

If you are unsure if an activity is or should be considered dangerous or if you are considering an activity not listed here, contact your Support Services Manager for verification.

**Driving is PROHIBITED:** operation of vehicles including all-terrain vehicles (ATVs), automobiles, electric scooters, snowmobiles, trucks, motorized trail bikes, go-carts, personal watercrafts, mopeds, and motorcycles is not allowed.

Students on the Dr. Walters policy are permitted to ride as *passengers* on the above vehicles, provided they follow all local laws and safety precautions; and as long as the vehicle is not racing. However, under no circumstances should a YFU student drive any vehicle (even if they have an international driver's license). Students may not take a driver's education course.

YFU students who drive any vehicle while on program will be recommended for early return to their home country.
